Be it remembered that a regular meeting of the Mayor and Board of Aldermen, Long Beach, Mississippi, was begun and held at 5:00 o'clock p.m., Long Beach City Hall Meeting Room, 201 Jeff Davis Avenue, in said City, it being the first Tuesday in June, 2021, and the same being the time, date and place fixed by Laws of the State of Mississippi and ordinance of the City of Long Beach for holding said meeting.

There were present and in attendance on said board and at the meeting the following named persons: Mayor George L. Bass, Aldermen Donald Frazer, Ronald Robertson (via telephone), Bernie Parker, Angie Johnson, Timothy McCaffrey, Jr., Mark E. Lishen, Deputy City Clerk Kini Gonsoulin, and City Attorney Stephen B. Simpson, Esq.

Absent the meeting was Alderman Patricia Bennett.

There being a quorum present sufficient to transact the business of the City, the following proceedings were had and done.

Alderman Frazer made motion seconded by Alderman McCaffrey and unanimously carried to add payment to Category 6, LLC in the amount of \$4,000 for Jeepin The Coast entertainment to the Docket of Claims number 060121.

Alderman Frazer made motion seconded by Alderman McCaffrey and unanimously carried to add New Business item #4 Discussion – Potential Zoning Issue to the agenda.

Alderman Johnson made motion seconded by Alderman McCaffrey and unanimously carried to approve the Regular minutes of the Mayor and Board of Aldermen dated May 18, 2021, as submitted.

Alderman McCaffrey made motion seconded by Alderman Lishen and unanimously carried to approve the Regular minutes of the Planning & Development Commission dated May 27, 2021, as submitted.

Alderman Johnson made motion seconded by Alderman Lishen and unanimously carried to approve payment of invoices listed in Docket of Claims number 060121, inclusive of payment of \$4,000 to Category 6, LLC for Jeepin the Coast entertainment.

It came on for discussion the disrepair of the Shoofly structure at the Town Green, whereupon Alderman Frazer made motion seconded by Alderman McCaffrey and unanimously carried to remove the wooden structure and re-assess the condition of the concrete slab at the next meeting of June 15, 2021.

The Mayor and Board of Aldermen of the City of Long Beach and took up for consideration the matter of a Resolution by the Mayor of the City of Long Beach pertaining to and asking The Mississippi Legislature to allow reallocation of Tidelands Grant funds remaining unexpended from prior years in the City of Long Beach as the Local Share of Hurricane Zeta Repairs. After a discussion of the subject Alderman Parker offered and moved the adoption of the following resolution:

A RESOLUTION BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF LONG BEACH, MISSISSIPPI ASKING THE MISSISSIPPI LEGISLATURE TO APPROVE AN AMENDED SCOPE OF WORK FOR THE FY2021 TIDELANDS PROJECT TO ALLOW USE OF TIDELANDS FUNDS AS THE LOCAL SHARE OF HURRICANE ZETA REPAIRS

WHEREAS, in prior years the Mississippi Legislature has appropriated tidelands funds through the Mississippi Department of Marine resources for various projects within the Long Beach Municipal Harbor; and

WHEREAS, as of the date hereof, the Long Beach Harbor is in a state of extreme disrepair caused by Hurricane Zeta; and

WHEREAS, in order to contract for and construct the repairs to the Harbor the City of Long Beach will an amended scope of work for FY2021 funds to be utilized as local share of Hurricane Zeta repair costs; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of The City of Long Beach, that the City does hereby respectfully request that the Mississippi Legislature authorize and allow the use of Long Beach Tidelands FY2021 funds for use as local share of Hurricane Zeta repairs costs.

RESOLVED FURTHER, that a copy of this proclamation is hereby directed to be filed with the Municipal Clerk of the City of Long Beach, and copies hereof be sent by the Clerk to all members of the Harrison County delegation of the Mississippi Legislature with the thanks and appreciation of the Mayor and Board of Aldermen of the City of Long Beach.

There came on for consideration at a duly constituted meeting of the Board of Aldermen and Mayor of the City of Long Beach held on 1st day of June,2021 the following Resolution, which was reduced to writing and presented in advance of the meeting for reading and examination:

RESOLUTION SEEKING THE ASSISTANCE OF THE HARRISON COUNTY BOARD OF SUPERVISORS IN PAVING WILKERSON LANE IN THE CITY OF LONG BEACH, AND FOR OTHER PURPOSES

WHEREAS, the City of Long Beach and the Board of Supervisors of Harrison County, Mississippi have heretofore entered into an Interlocal Agreement to allow and provide for the exchange of services and the provision of assistance between them on behalf of the citizens of Long Beach and Harrison County; and

WHEREAS, from time to time and on occasion the City has sought the assistance of Harrison County in paving roads, public parking lots and other public areas in need of repair, and the Harrison County Board of Supervisors has generously responded and complied whenever possible with such requests; and

WHEREAS, Wilkerson Lane in the City of Long Beach has suffered extreme deterioration due to use, wet weather conditions, construction activity, and other causes which may possibly cause this street to deteriorate to the point of being in a hazardous condition and threat to public safety; and

WHEREAS, being without sufficient resources and proper equipment to pave such public street, the City of Long Beach hereby seeks the assistance of the Harrison County Board of Supervisors to pave or resurface so much of Wilkerson Lane as has heretofore been accepted as a public street and right of way by the City of Long Beach and

open to the public with rock, gravel or such other appropriate maintenance materials as available and proper for the use, protection, health and safety of all citizens of Harrison County, with the City to thereafter maintain said roadway as may be required in accordance with the City's standard maintenance practices and requirements.

NOW, THEREFORE, be it resolved by the Board of Aldermen of the City of Long Beach that the Harrison County Board of Supervisors be, and same hereby are requested to provide such assistance as may be available to the citizens of Harrison County in the City of Long Beach in the form of resurfacing so much of Wilkerson Lane in the City of Long Beach as has heretofore been open to the public for such street is in need of resurfacing and for which purpose no municipal funds or resources are available, with the City to thereafter maintain said roadway.

BE IT FURTHER RESOLVED, by the Mayor and Board of Aldermen of the City of Long Beach that we express our appreciation to Supervisor Marlin Ladner and the entire Harrison County Board of Supervisors for any assistance it is able to provide in this request.

It came on for discussion On Street Parking, whereupon Alderman Frazer expressed his concern of areas within the City, specifically Old Town Gardens, where on street parking is causing traffic issues. After discussion, it was the consensus of the Board to table this item until the next meeting on June 15, 2021.

It came on for discussion Potential Zoning Issue, whereupon Alderman Frazer questioned the need for specific zoning for medical marijuana dispensaries should they once again become legal. After further discussion, it was the consensus of the Board to schedule a work session at the July 6, 2021 meeting.

It came on for discussion the traffic signals at Klondyke and Commission Roads, whereupon Mayor Bass asked Public Works Director Joe Culpepper to update the Board on their status. Mr. Culpepper stated that the cost to repair the pole and signals to their pre-accident state would be approximately \$15,000 and these repairs needed to be made prior to MDOT repairing the Hurricane Zeta damage. After further discussion, Alderman Parker made motion seconded by Alderman McCaffrey and unanimously carried to authorize the repair of the pole and signals.

The Mayor provided an update on the repair of Hurricane Zeta damaged fencing at the Cemetery.
